

## **COURSE DETAILS**

**Length of Course:** 25 hours total spread over the eprep time and a 4 day period.

See your confirmation for exact meeting times.

**Cost of Course: \$371.43 plus \$18.57 GST = \$390.00**

(Please note the course cost does not include: Lift Tickets, Accommodations, Meals or Transportation.)

## **ELIGIBILITY**

- Strong parallel skier (willing and able to ski a black run if required), **minimum of 15 years** at the time of course.
- Knowledge of CSIA skiing skills will be beneficial although not required. Reading and course information (Eprep should be done prior to course start) is available on line at [http://www.snowproab.com/skipro/course\\_materials.htm](http://www.snowproab.com/skipro/course_materials.htm)
- It is suggested that candidates have their skiing skill evaluated by a current Level 1 Course Conductor or Level 3 or 4 CSIA Instructor, prior to attending the course. If you require assistance please contact CSIA (Alta) Level 1 or your local Ski School.

## **COURSE CONTENT**

- A 25 Hour program designed to better develop skiing, guest experience and teaching abilities of potential ski instructors. Included in this time is your eprep time of about 2 hours.
- Teaching strategies will focus on developing skiers from beginner to parallel.
- Candidates will receive feedback on their personal ski performance and ability to demonstrate CSIA Technique.
- This course is a PASS/FAIL evaluation based upon candidates' skiing, and understanding of the guest experience, and teaching concepts presented.
- Candidates must pass guest experience, skiing and teaching components to be certified as CSIA Level 1 Instructors.

## **POLICY / PROCEDURES**

### **CANCELLATION POLICY**

- Courses will be conducted as scheduled.
- In the event a participant for any reason is unable to attend the course, notification must be made to the CSIA (Alta) Level 1 office at 1 888 777-0444 or 403 609-2966 2 weeks prior to the first scheduled day of the course for a full refund. Otherwise a \$50 administration fee will be charged.

### **REFUNDS**

- a \$50 administrative fee will be charged for any refund, cancellation or transfer except for medical reasons (Doctor's certificate required)
- A full refund will only be provided when course organizers cancel a course.
